We were one of the leading councils in the just completed "Wheelchair Sunday."

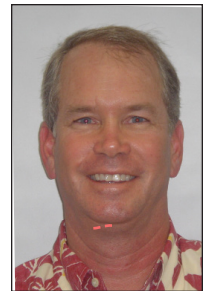
At this juncture we are also on pace for "Star Council." The three key areas are: Father McGivney award, Founders Award and Columbian Award.

# Successful recycle program is generating income for Council on a year-round basis

## Weekly Program:

Every Monday and Tuesday of the year, a few great people show up at two mobile home parks to pick up papers and deliver them to the fabled “barn” in back of the church hall.

To those who consistently show up on one or both of these days, I cannot thank you enough. For those others who make it whenever their work schedules allow (and that seems when you're needed the most) we say thank you.

And a special thanks goes to the five members of the team (two men, three women) who are not Knights.

In addition to the mobile park program, this group handles special pickups that can occur any time, such as the Penny-Saver (twice a month), book pickups (weekly), church missals (twice a year from three parishes), and brochures and engineering paper (on call from several companies).

Many of these products require additional processing before they can be sent to the recycler.

Recognizing that most of the weekly program requires pickup and delivery, the total work effort requires lifting over 410,000 pounds of paper product a year.

Not reflected in the numbers above is a substantial amount of plastic, glass, and aluminum that is collected or dropped off at the church and held for the monthly program.

### Monthly Program:

On the second Saturday of each month we set up the lower Church parking lot to collect paper, plastic, glass and aluminum from our parishioners and the general public.

In addition, we collect these products from the same mobile home parks we service during the weekly the program.

Around 6 a.m., a few dedicated Knights show up to set up for the day, which begins at 7 and will last until closing at 12 noon.

Clean up and a little fellowship follows for those who are able to stay. Again, my thanks to those who have accepted leadership roles, those who consistently man this program every month and for those who can squeeze some time from their busy Saturdays to help.

This program can be very labor intensive for the five hours it operates; the public must be serviced in a timely manner so they will return consistently. All products must be sorted properly to gain the best revenue from the product.

Although we are grateful to our teens who work for service

## *Added funds needed for recycle area*

We are requesting from the Council an additional \$7,500 allocation to complete the original request to fund the construction of the new recycling area.

The original \$15,000 estimate was based on partial data that did not meet all the specifications set forth in the final drawings and meeting with John Blaney, Construction Supervisor.

John did a preliminary study of the plan and defined more precisely the specific needs and requirements to be met.

We have had three bids, for \$19,750, \$27,709, and \$22,200. A Brother Knight's bid of \$14,500 was resubmitted at the last Officers Meeting.

A final contract must be drawn up and all items in the bid clarified and accepted.

We also have the original cost of the plans and the \$1,000 that needs to be paid to the city of Lake Forest. A committee of John Blaney, George Nothhelfer, and Bob Morgan has been formed to supervise the project.

The additional amount is to cover the costs over the initial \$15,000 plus any contingencies. We're close to the final goal and don't want to hold anything up.

It is the committees' intent to complete this project for the least expense to the Council, in the most efficient manner possible.

Your Officers will also have oversight on the monies spent.

We do not expect to use the total amount of \$22,500 but we need to insure that adequate monies are available to pay contractors and all parties involved in this construction.

still need Knights to help process the products that come in and supervise the teens.

We face into our most difficult times when the school year is out and the teens are not able to help. Needless to say, it is extremely hard work when only a few Knights show up to work on one of those Saturdays.

The monthly program produces over 67 percent of the total revenue from recycling.

### Next Year's Outlook

Recycling will remain the number one money maker for the Council. However trends are down in revenue and weight primarily due to fluctuations in paper rates and volume.

Generally, newspaper volume seems to have stabilized for now, but the trend is for less print news and more Internet news which will have a future negative effect.

We have also suffered a reduction in special program collections due primarily to the relocation of the Penny-Saver. I cannot emphasize enough that our membership needs to be alert for opportunities for special collections, i.e. engineering paper, office file clean up, company brochures and catalogs.

Finally, we have experienced a significant decrease in the rate we are receiving for paper. The rate for paper and other products are market based and may fluctuate. Other recycle products seem steady in volume and rates.

With our new recycling facilities, we may be able to turn to some new sources for recycling products.

But remember: **with new sources comes additional work, so Brothers, please be ready to get involved.**
