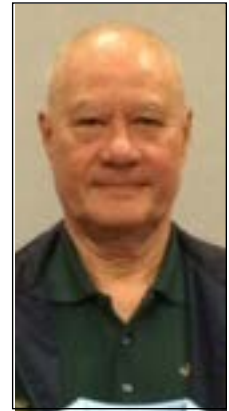

Insurance through work doesn't work

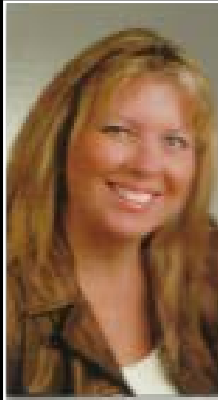
