Knights offer a portfolio of protection

complete portfolio of protection to our members. It's our best yet, with high quality, customizable products designed to fit your family's needs and budget.

Permanent life insurance is our signature product because it provides guaranteed protection for your loved ones until the day you die. And, while you're still alive, it builds cash value. It's the total package.

Permanent life is a great solution for many basic needs, such as final expenses, income replacement, and debt protection. It can also serve specialized purposes such as estate planning and charitable giving.

Whatever the planned use, permanent life insurance is reliable. It will be there when you won't be, regardless of when that happens.

Simply put, as long as you pay your premiums, whenever you die, your beneficiaries will receive the guaranteed death benefit (if not more) that you established for them.

There is one exception, though. Should you be fortunate enough to live to the ripe old age of 120, your KofC permanent life insurance policy will pay your death benefit. It wouldn't be the worst 120th birthday present you receive.

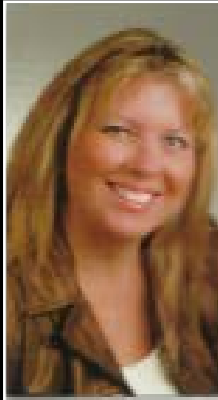
